# No More Plastic Yard Waste Bags!

The single family section is obligated by law to have a special yard waste. Fairfax County is phasing out the use of plastic bags for yard waste collection. This will reduce the amount of plastic in our natural environment. When yard waste – brush, leaves, and grass – is processed into compost, small pieces of shredded plastic end up in the organic material spread in gardens, yards, etc. Even the best screening systems don't remove all the plastic shreds.

Instead of plastic bags, residents should use compostable paper bags or a rigid container clearly marked yard waste. Other options include composting and mulching at home and grasscycling (leaving mowed grass clippings on the lawn).

Acceptable yard waste includes grass clippings, leaves, straw, brush, small prunings, branches, and flowers. Unacceptable material includes tree stumps, food waste, lumber, treated wood, pallets, sawdust, dirt, mulch, and sod.

It has been a couple of years since we have addressed our feral cats in the community. A couple of years ago we did a sweep through the Newington community and had all the cats spayed/neutered and shots. Since then, we have not been aware of any new cats. If you see a cat on our streets that is not an "owned" cat (usually wears a collar) or does not have their "left" ear tipped, please let us know so we can have that cat or cats taken care of. We are also in the beginning of kitten season, so please let us know if you see any kittens so we can also have those trapped and hopefully re-homed.

This brings me to our next dilemma with the feral cats. We had a wonderful lady in our community that had lived here for 20 years. She was feeding 15 feral cats daily. Yes, that is a lot. She was feeding the cats with her own money. After 20 years, the landlord decided to do something new with the townhouse and she had to move. This has left 15 cats that still need to be fed. Her neighbor has offered to put food out for the cats, but he cannot afford to feed those "15" plus the "5" cats he already feeds. We are hoping our community can come together with donations to help feed these kitties. They eat both wet and dry cat food.

Minutes of the Meeting of The Board of Directors John Nolan Meeting Room March 4, 2020 - 7:00 pm

**CALL TO ORDER:** Meeting was called to order at 7:00 pm by President Cerchione.

The meeting was recorded.

**BOARD MEMBERS PRESENT:** President Amber Cerchione, Vice President Regina Watson, Treasurer Bobby Royal, Secretary Karen Chauvin, and Director Debby Ramirez.

**MANAGEMENT PRESENT:** Lori Randall

**OTHER ATTENDEES:** 6 residents

**PRESIDENT'S COMMENTS:** With warmer weather, there are lots of children playing outside, so everyone needs to watch their speed on NCA streets.

#### **COMMUNITY FORUM:**

- A resident commented that children should not be playing in the streets. Streets are for cars, and yards are for children. [A reminder will be put in the NCA newsletter.]
- A resident stated that there are several feral cats on Matisse that have been neutered and have had their shots, but the person who took care of the feeding station has moved. The resident would like to ask for assistance/donations to help with feeding the cats so they do not tear up trash bags looking for food. [The resident may put an article in the NCA Newsletter.]
- A resident commented that there is a lot of trash by the wooded area on Matisse and on Euclid Way. [NCA needs a volunteer to organize "Clean Up Day" in April around Earth Day.]

#### **Article V of the Architectural Standards**

The Board has revised all of Article V of the draft Architectural Standards included in the February newsletter. The proposed new Article V, in its entirety, is as written below.

All recent updates to the Standards will be on the agenda of the April Board meeting. Anyone who would like to share their comments may do so during the Homeowner Forum section of the April meeting or by email to the NCA office.

ARTICLE V – SCREENED PATIO ENCLOSURES AND DECKS FOR HOUSES (11/93, 8/07, 8/17, xx20)

Section 1. Definition: (8/07,xx/20) A patio and/or deck enclosure is an add-on structure permanently attached to the house with screened sides and a roof. Fairfax County classifies screened porches as additions. A patio enclosure would be a ground level structure. A deck enclosure may be first level or second level. Enclosures are not intended for year-round use and are not connected to the central air conditioning or heating system of the primary structure. A second level deck floor may not be a first level enclosure roof.

Refer to Article IV – Decks, Sections 1, 2, 3, and 4 for information on Notification of Neighbors, Requests for Approval, Materials, and Overall Requirements.

Refer to Article III – Additions, Sections 5 and 7 for information on the roof, windows, or doors.

# **Changes Proposed to Parking Policy**

Due to concerns about the enforcement ability of item 7 in the NCA Parking Policy, the Board, after serious consideration, has determined that it would be prudent to remove this section from the Policy.

No other change to the Parking Policy is being considered at this time.

The Board would greatly appreciate receiving comments on this proposed policy change at or prior to the April 1st Board meeting!! You may also email comments to manager@newingtoncommunity.org.

The following is an excerpt from the NEWINGTON COMMUNITY ASSOCIATION PARKING AND TOWING POLICIES dated March 6, 2019 that would be removed by this proposed change:

7. Must not obstruct the view of drivers while they are exiting their parking space or attempting to navigate the street. Vehicles not meeting this requirement will be issued a warning ticket and towed after 10 days. If the same vehicle is found to be in violation again, it will be towed without another warning.
